DETAILS

We are excited to open up to new vendors for the Chester County Balloon Festival in 2022, our 14th year! We welcome you to join us in getting your product or services in front of thousands of people by becoming an exhibitor. This year's expected attendance is approximately 20,000+ people. This will be our second year at The Willowdale Steeplechase grounds. 2021 proved that the grounds are perfect for every vendor. Everyone was pleased with their placements because of the easy flow of spectators across the spacious and lush, green grass of the event space. The feel was of "country living" and open space that is quintessential Chester County. Besides its' convenient location near the historic town of Kennett Square and great access points on Rts 82 and 926; we are thrilled to be back here once again.

There will still be areas on and from the pavement. Vendors will be set up on a first-come, first-serve basis. Electrical service is limited. The layout and spaces are subject to change. However, we have so much more versatility, no hidden-away spots, all with high visibility and high traffic.

The festival is a rain or shine event, the balloon flights and glows are not. If the balloons are a no-go, then YOU become the show. Participants are still able to make purchases, listen to music, and eat and drink during inclement weather. In the case of severe weather conditions and roadways are closed, please check our website or social media for updates on the festival status. Also, please be sure to check the "No longer accepting" list on the website for the most up-to-date information on vendor eligibility. **All vendors must sign up for the entire three-day event and commit to stay until close each day. There will be no exceptions. Violators will not be invited back again.**

CLASSIFICATIONS & SPACES

Classifications types:

- **Arts & Crafts:** 70 percent or more of your products must be handmade
- **Retail:** Retail products for sale that are not handmade
- **Commercial:** Corporations, contractors, or service businesses
- **Food Trucks:** Vendors who make fresh food onsite
- **Nonprofit:** 501(c)(3) with proof of entity required

Spaces:

- Payment is due 10 days or seven business days after application submission by check or money order made out and mailed to the Chester County Balloon Festival, P.O. Box 711, Paoli, PA 19301. If payment is received before granted approval and not accepted, the check will be returned.
- We will accept Venmo upon request.
- Electrical outlets are \$75 each and are limited and on a first-come, first-serve basis.

SET-UP



Exhibitors should plan to arrive in time to unload and remove all vehicles from the area **ONE HOUR BEFORE GATES OPEN** to the public: **11:00 a.m.** on Saturday and Sunday. If you require a lot of room to pull in a trailer, contact the festival to discuss the best access prior to pulling into an area. **Vehicle access to the vendor area will be prohibited during public hours. There will be no exceptions and violators will be removed from the property, and not invited to future events.**

- Prices are per space.
- All spaces are reserved for Saturday morning through Sunday.
- All vendors are requested to register by August 30th in order to gain acceptance into the festival. In addition to the higher space cost, late fees may also be assessed.
- Except for **total** event cancellation due to unforeseen circumstances beyond the Chester County Balloon Festival's control, **no refunds** will be considered.
- Vendors who have participated the previous year have the first right of refusal for their space the following year. Space availability is based on vendor turnover.
- Vendors may bring their own low noise generator.

REGULATIONS

- All exhibitors must provide their own tables, tents, and/or equipment. This is held in a wide-open field, so please be prepared. These items can be left on site—please remove any valuables as the festival will not accept responsibility for any stolen or damaged items.
- **Limited** electrical service is available. Make sure to indicate if you will need electricity. Additional fees will apply. Appropriate three-wire grounded cords are required and availability is the responsibility of the vendor.
- **Vendors must clean up their space during and at the close of the festival, including the removal of all trash to the onsite dumpsters.** Violators will not be invited back next year. Trash dumpsters are provided. And please take what you can with you.
- Food vendors must include a \$100 deposit in addition to the space fee. See the Food Vendors section below.
- **No pets are allowed in the parking or festival areas.** You will be asked to leave and forfeit your fee.
- **Space is reserved on a first-paid basis.** We will try to honor exclusivity requests on a first-come, first-serve basis, so make sure to get your application in early. **Be specific** on those items that you want to be made exclusive. You **must** participate in all three days to be granted exclusivity and not all requests will be accepted.



- Payment in full by check or money order only must be received within seven business days of your electronic application. (address below) If your application is denied, your payment will be returned. Your space will not be considered reserved until your payment is received. Venmo payment will be accepted upon request.

FOOD VENDORS

- Food vendors must send two checks: one for your space and a second, refundable check for \$100 to be returned if your space is left clean.
- Dumpsters will be onsite and trash cans will be emptied throughout the day. Volunteers may offer to take bagged trash from the area around your space. Please don't count on our volunteers being onsite when you need them. **It is your responsibility to keep your area clean.**
- Food trucks must be:
 - Self-contained
 - Motorized
 - Self-sufficient on water and power
 - Generators must have snorkels and be low noise
 - Painted nicely

- Valid Chester County Health Department Food Permit is required.
 - Call the Chester County Health Department at (610) 344-5938 or visit <https://www.chesco.org/food>.
- Exhibit spaces with water connections are sold out. Food vendors must plan on bringing their own water.
- All food vendors must provide a Certificate of Insurance to the festival organizers with their application and payment.
 - The general liability must be no less than \$1 million per occurrence.

 - The Certificate must also indicate that coverage is in effect for the entire period of Friday, Sept. 9 through Sunday, Sept. 11, and must contain the stipulation that the Chester County Balloon Festival shall receive, at least 10 days prior, a written notice of cancellation or modifications.
